EXPERIENCE:

While still attending law school, I worked just about any job available to put myself through school. Prior to graduation in 1978, I was fortunate to find a position working under one of the best personal injury attorneys in this area of Florida, A. Dallas Albritton, and with his good friend, B. Anderson ("Bob") Mitcham, who was known state-wide for his criminal defense expertise. Having a strong background in law enforcement, I gravitated towards this area of work, but within a year or two, it became clear that my real "calling" was in Family Law, and I have focused my practice on that ever since.

Whether working in my own practice as a sole practitioner or working with the firm Bob Mitcham, Rex Barbas, and I built in 1981, I have focused my efforts on Family Law. Mitcham, Weed, & Barbas flourished and grew into a healthy law firm with several more partners and associates, providing services in most regularly needed areas of law. Our firm was always "AV" rated by Martindale-Hubbell, and the partners became very well known in their respective fields of law. I was honored to become Board Certified in Marital and Family Law the first year that it was offered to attorneys, 1985.

Time changes and law firms do, too. My "brother," Bob Mitcham, took the Bench as a Circuit Judge in 1991, and Rex Barbas followed him in 1997, also as a Circuit Judge. In May 2003, I left the law firm that had evolved from our original one and started my own private practice, specializing in Marital and Family Law.

In the 33 years I have been practicing, I have represented hundreds of people from every walk of life and many from other countries. I enjoy representing a diverse cross-section of our society. Thus, there is no "typical client" in my office. My practice now tends to gravitate towards cases with difficult parenting and co-parenting issues and detailed financial matters. My goal is to wrap up each case within six months, but some are so complicated that they take much longer.

At no time during my practice have I ever strayed far from legal education. In fact, I attend almost every course offered by The Florida Bar and the Hillsborough County Bar. Also having a healthy practice in my home county, Hernando, I was honored to be asked to join the Inns of Court for Hernando – Citrus Counties. I also participate in a Hillsborough County Inn of Court that specializes in Marital and Family Law. Recently, I joined the Association of Family and Conciliation Courts so that I could increase my knowledge in psychological issues relating to my field of law and provide the best information concerning parenting issues.

In 2010, I was honored to be asked to teach "Florida Civil Procedure" for Stetson University's College of Law, and then asked back for 2011. This has woven nicely into my private practice, and I look forward to teaching again for the Fall 2012 semester.
